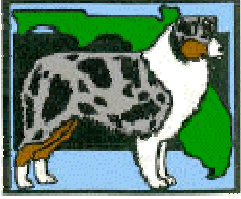

The objectives of FASA shall be:

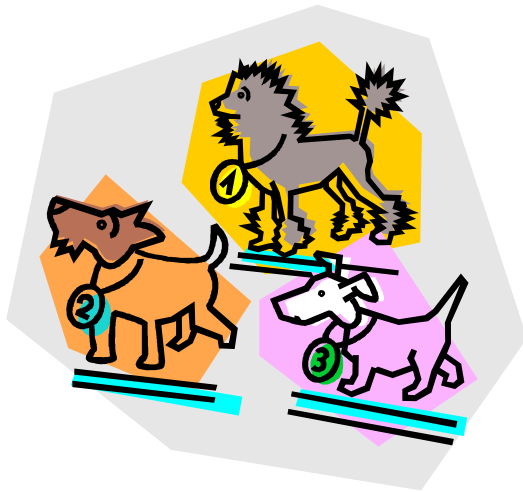

November 11<sup>th</sup> – 13<sup>th</sup> we will be having a Stock Dog Trial in Groveland, FL. November 25<sup>th</sup> – 26<sup>th</sup> we will be having Obedience, Rally and Conformation in Ocala, FL, and December 17<sup>th</sup>-18<sup>th</sup> we will be having an Agility Trial in Zephyrhills at Pasco Paws. 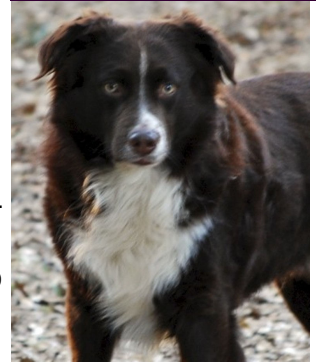
We will be having a General Meeting with election of FASA Board Members at the show in Ocala on November 26<sup>th</sup>. The board members serve a two year term. As per the club by-laws, nominations of persons can only be made if the person is present to accept the nomination or if they have given a written acceptance of a nomination in case they will not be able to be present at the meeting. We are still looking for someone to fill the secretary position for the remaining one year left before the election of officers in 2012. Please contact me if you have an interest in filling this position or have any questions.

If anyone has any suggestions of an educational event we might have in 2012 please let me know. Several years ago one of the affiliate clubs in FL brought in C.A. Sharp for a seminar on Aussie genetics. It is possible if there is enough interest we could do something along those lines. In the past we have had a tracking seminar and a handling seminar. This year we had an eye clinic.

We are in the planning stage for the 2012 show year. I know we will be scheduling a Tracking Test and a Stock Dog Trial in the first couple of months of the year as well as a time for our Year End Awards. If anyone would like to put on a show we will work with you to make that happen. Several events have longer lead times for sanctioning so if there is an interest now would be a good time to be thinking about this. We have the equipment to hold shows outdoors and indoors and are in the process of purchasing a larger trailer which would facilitate moving our equipment to different locations. 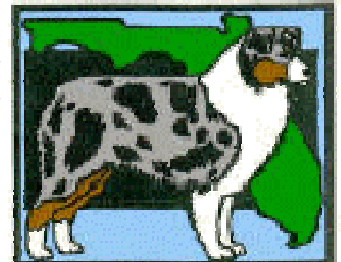
