Directions to show site: PASCO PAWS, 3137 Diana Drive, Zephyrhills, FL 33541. From I-75, exit number 279, Hwy 54. Go east towards Zephyrhills, 7 miles. Home Depot on the left, turn right on Morris Bridge Rd (CR 579). Go to the stoplight (0.7 miles) and turn left. Go 1.7 miles to Diana Dr, and turn right. The property is on the right about 0.3 miles. From I-4, exit number 7, Hwy 301. Travel north on Hwy 301 for 19 miles towards Zephyrhills. Turn left at the first light, Chancey Rd. Go about 2 miles and turn left onto Diana Dr. The property is on the right about 0.3 miles
