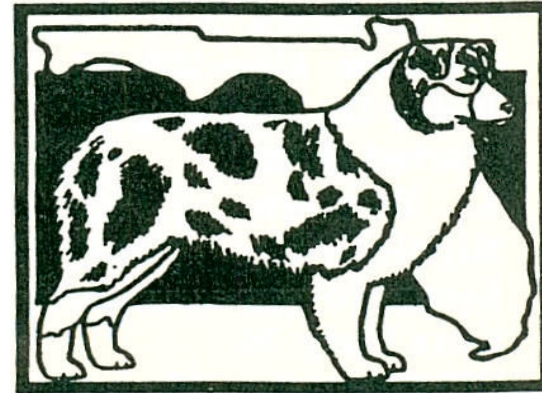

Rules and Regulations

All dogs must be **ON LEAD** while not competing or warming up. Please bring your own water for your dogs. The only available water is well water.

Exhibitors who do not clean up after their dogs at the trial site or at their motels will be dismissed from the trial. Anyone causing problems at their motel will be banned from future agility trials held by FASA and ASCA will be notified.

Exhibitors, through submission of an entry, acknowledge that they are knowledgeable of ASCA rules and regulations including, but not limited to, the following rules regarding entry:

All healthy, trained dogs over eighteen (18) months of age are eligible to compete in ASCA agility trials. Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog. Any dog which demonstrates aggression towards any person or any dog, whether inside the ring or outside the ring, must be excused from the agility trial. Any dog which the judge feels is not in enough control to perform all obstacles in a safe manner will be excused from the agility trial. All ASCA agility trials shall be open to purebred and mixed breed dogs.

No leads, collars, food, toys or other aids or training devices shall be allowed on the course at any time or within 10 feet of the ring.

The organizing committee may refuse any entry as provided by ASCA Rules and Regulations. Anyone not in good standing with ASCA will not be allowed at this trial.

RETURNED CHECKS do not constitute a valid entry fee. There will be a \$25.00 fee for any check returned

All dogs must be individually registered with ASCA in order to get credit for qualifying scores. An ASCA registration number is not required for entry. A form is included in this premium to get a tracking number for your dog.

Obstacles to be used in the trial will include the dog walk (slatted), A-frame (slatted), teeter-totter, open tunnel, closed tunnel (chute), weave poles, winged single hurdle(s) and non-winged single hurdle(s).

Facts about ASCA and our Trial

Once your dog completes a title, you have the option to move up to the next level (on the next day or the next show) or to remain in your chosen level to compete for additional ASCA titles - such as the Superior Performance awards.

Junior handlers have the option of jumping the dogs at their std jump height and still receiving additional 10% in time.

Notice to Exhibitors:

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from completion by action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbance, acts of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Welcome to the FASA ASCA Agility Trial! This trial is open to all breeds, and will be held under the rules of ASCA.

Entry Closing Date: All entries must be RECEIVED by 6:00 p.m. Monday, September 26, 2011. No entries may be accepted after the closing date. Entries may not be changed, altered or withdrawn after the closing date except in two cases:

- 1) A dog receiving a title after the closing date may be "upgraded" to the next higher level by notifying the secretary before 10/3/11.
- 2) Bitches in heat may be withdrawn and the entry fee (less \$5.00) will be refunded upon request of the exhibitor prior to the beginning of the trial. Request must be accompanied by a veterinarian's statement.

There shall be no refunds for entries withdrawn after the closing date for any other reason, or in the event that a dog and/or handler are dismissed from competition, regardless of reason for such dismissal.

Location: This trial will be held at a private residence, 3137 Diana Dr., Zephyrhills, FL, and will be outdoors on grass. There will be Port-a-potties.

All small and medium dogs must be measured.

Dogs with permanent height cards from either AKC or NADAC do not require measuring. Please send in a copy of card with entry, or present it at check in.

Prizes & Awards: Ribbons will be awarded for 1st thru 4th place in each jump height for all classes in all Divisions. In all classes, each qualifier will receive a qualifying ribbon. The 16" and 16+" veteran classes will be combined for prizes.

Please remember - dogs are not to wear collars of any kind while competing on a course. "Run naked!"

ASCA Service Membership and Tracking Number Application

Beginning 1/1/2003 for non-ASCA registered dogs – In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership type of ‘Service’ is required). ASCA membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA qualifying legs earned from 1/1/2003 until submission of application.**
